Community Scouting

Narragansett Council extends the benefits of Scouting to youth outside traditional units through Community Scouting programs. These initiatives provide leadership development, teamwork, and outdoor adventure opportunities to participants in summer camps, leadership field trips, and day programs. Activities like swimming, target sports, teambuilding and skill-building challenges offer transformative experiences, ensuring more young people could grow, connect, and benefit from Scouting's values.





Community Scouting: Expanding Access to Scouting Adventures

The Council introduced homeschool programs at Adventure Base Camp at Camp Champlin and at Camp Norse in Plymouth, engaging youth in Scouting principles and skills during weekdays when the camps are typically underutilized. Activities such as nature exploration, survival skills, leadership, and community service projects provide homeschoolers with hands-on experience and practical knowledge aligned with Scouting's core values. This approach maximizes camp facilities and offers a unique educational environment for homeschool families.

Through these Community Scouting programs, we have broadened our reach, making Scouting accessible to a more diverse group of young people. By leveraging underused weekday times at our camps, the Council ensures more youth benefit from Scouting's enriching experiences. These programs foster personal growth, resilience, and a sense of community, helping participants develop into well-rounded individuals equipped with essential life skills.

Turtle Trek Camporee Hosted by Tulpe Lodge, Order of the Arrow

Youth Leaders Organize Amazing 3-Day Camporee

In November, Tulpe Lodge hosted the Turtle Trek Camporee that was attended by more than 400 people at Camp Norse in Plymouth, Massachusetts. The Order of the Arrow is Scouting's National Honor Society and each "Lodge" is led by its youth officers and members. Tulpe Lodge youth members worked for more than a year to plan, promote, and deliver this excellent weekend camporee for Scouts BSA members. Troops from around the council and many surrounding councils attended.

It was Tulpe Lodge's largest, and most exciting event in years. Scouts participated in dozens of activities including axe throwing, field games, target sports, fry-bread making, awesome evening shows, escape room challenges, ham radio, and more. Special thanks to event chair and Tulpe Lodge Chief Drew Helm and the more than 40 OA members that helped organize and staff the 3-day, 2-night camporee.





Exploring, our coed teen career program, continues to grow!

Our Exploring membership increased by over 7% in 2024. We currently have 8 Law Enforcement Posts and 3 Fire/EMS Posts. Our Exploring program teaches important life and career skills to young people from all backgrounds through immersive career experiences and mentorship provided by community and business leaders like you. Together, we equip young people with character, leadership and life skills that can be used both today.



Law Enforcement Explorer's Stations Day: April 13th

This spring, we partnered with the Rhode Island National Guard to host our annual Law Enforcement Stations Day at Camp Fogarty. Co-ed explorers aged 14-20 competed in various activity stations, demonstrating their knowledge and gaining hands-on experience in law enforcement careers. Highlights included a Top Shot tournament and a simulated Humvee rollover, thanks to the National Guard. The event saw participation from 42 explorers representing 7 Police Posts.

Law Enforcement Exploring Academy: June 23rd-29th

In June, we partnered with the National Guard to host the Police Explorer Academy at Camp Varnum in Narragansett. Police Explorers spent a week working with professional law enforcement personnel, developing skills for potential future careers. They received both classroom and hands-on instruction, participated in demonstrations, and competed in activities such as handcuffing, building clearing, crash investigation, and cyber security.

Leader Training



We are blessed with 3,079 outstanding volunteer leaders that deliver Scouting to youth throughout Southeastern New England. These volunteers help in many different ways as unit leaders, on parent committees as well as on district and council committees and the executive board.

The number of trained volunteer leaders reached an all-time high, marking the 10th consecutive month of increases, with several hundred new fully trained volunteers.

For the first time, we offered an Introduction to Cold Weather Camping Training for troop leaders at Camp Yawgoog to better prepare Scout groups to have successful, enjoyable winter activities.

Leader training programs included Leaderpalooza, Basic Adult Leader Outdoor Orientation (BALOO) for Cub Scout leaders, and Introduction to Outdoor Leadership Skills (IOLS) for Scouts BSA leaders.

Other unique training programs planned for the new year include New Leader Onboarding Workshops, Mental Health and Wellness sessions for leaders and troops, Safety Workshops, and Mental Health and Suicide Prevention training for Scouts aged 11 and older with a parent/guardian.

Philanthropy

34th Annual Moby Dick Scouting Golf Classic:

A full field of 128 golfers participated in the Moby Dick Scouting Golf Classic at Montaup Country Club, with Saint Anne's Credit Union as the Presenting Sponsor. For the first time in the event's history, 32 foursomes were fielded. Chaired by Jack Ledwidge from Saint Anne's Credit Union, the Classic raised a record-breaking **\$66,728** to support our Scouts. Over 34 years, this event has raised more than **\$900,000**.

7th Annual Sporting Clays Classic:

Addieville East Farm in October was the perfect venue for the Sporting Clays Classic. The event featured 14 challenging clay shooting stations, a flurry shoot of 50 clays, a hearty breakfast, a steak and game lunch, live music, and live and silent auctions. Everyone had a blast! Good Scout Award:

The Good Scout Award Dinner recognizes outstanding community leaders who exemplify the Scout Oath and Law daily. These leaders inspire others to positively impact lives. Robin Cuddy, former Executive Director of the Attleboro Y, and Mark Cuddy, Executive Vice President of FB Insure, were honored with the 2024 Good Scout Award. Presented by Bristol County Savings Bank at the Norton Country Club, the event raised nearly **\$35,000**.

Annual Popcorn Sale:

The Annual Popcorn Sale is our primary fundraiser to help Scouts and units raise funds for their programs. In 2024, our Scouts sold **\$378,837** worth of popcorn, with over 71% of gross sales staying locally to benefit the Scouting program. Ten units from multiple districts sold over **\$10,000** of popcorn, with Pack 12 North Attleboro leading the way by selling **\$40,885** to fully fund their Scouting year! Units earned **\$171,676** in profit and prizes for Scouts.
